Then you can start unlocking even more rewards that Blue Cross Blue Shield of Massachusetts will automatically deposit into your HSA—in addition to your employer's contributions.

Earn incentives for your financial well-being

- **\$50** for registering with HealthEquity® and using the HSA Plan Optimizer Tool. HealthEquity is an independent company that administers your HSA.
- **\$50** for personally contributing at least \$1 in your HSA
- **\$100** ahealthyme Rewards® Program per quarter for engaging in healthy habits—for a total of **\$400/year**.

Get fitness and weight-loss reimbursements

Employees who want to save more can contribute additional funds from payroll or via direct deposit to achieve the 2022 maximum annual contribution of **\$3,650 / \$7,300**. Anyone 55 years or older may contribute an additional **\$1,000** as a catch-up contribution.
