Pharmacy Benefit Update for Statins, Effective December 1, 2017

To comply with new United States Preventive Services Task Force recommendations, starting December 1, 2017, the following statin medications won't require a cost-share for employees with no history of cardiovascular disease (CVD) (for example, symptomatic coronary artery disease or ischemic stroke) between the ages of 40-75, who have one or more CVD factors (dyslipidemia, diabetes, hypertension, or smoking), and have a calculated 10-year risk of cardiovascular event 10% or greater.

The following medications will be covered at no cost (qualifying members only):

- Atorvastatin 10-20 mg
- Fluvastatin IR and XL 20-80 mg
- Lovastatin 10-40 mg
- Pravastatin 10-80 mg
- Rosuvastatin 5-10 mg
- Simvastatin 5-40 mg





On January 1, 2018, we'll require prior authorization for all imaging and sleep services included in our programs. AIM Specialty Health (AIM) will manage authorizations. AIM has experience managing imaging and sleep services for our members, as well as for most other Blue Plans with approximately 42 million lives under management across the country.

Get Your Flu Shot

The flu can best be prevented with the current flu vaccine, which is updated annually to most closely match the recent viral strains. We make it easy for members and their families to get vaccinated. This flu season, we're offering the vaccination at a range of provider, workplace (if administered using a Blue Cross Blue Shield of Massachusetts contracted vendor), and pharmacy-based locations. Coverage depends on the plan type and the nature of the care received.

For the 2017-2018 flu season, the CDC recommends against using the nasal spray flu vaccine, commonly supplied as FluMist. As a result, Blue Cross Blue Shield Massachusetts won't cover this type of vaccine for this flu season.

We're partnering with Ovia Health™, an independently owned and operated company, to share Blue Cross Blue Shield of Massachusetts maternity benefit information with your employees through the Ovia Pregnancy app.

Once your employees download the Ovia Pregnancy app and select Blue Cross Blue Shield of Massachusetts as their health plan, they can:

- Get timely reminders about Blue Cross maternity benefits, such as Find a Doctor & Estimate Costs tool, call-in maternity support, and a no-cost breast pump and reimbursement for childbirth classes that may be included in their plans
- Call a Blue Cross Nurse Care Manager from within the app when high-risk symptoms or conditions are reported
- Track symptoms, nutrition, weight changes, and doctor appointments
- Log milestones and learn about baby's weekly development



ACA Member Months Coverage Report Available for ASC Accounts

All our Administrative Services Contract (ASC) accounts will have access to a tax reporting service, which follows the Affordable Care Act (ACA) guidelines. As part of our continual efforts to provide service enhancements, we'll once again give you the choice to have us run your Member Months Coverage Report at no cost. This service is available to ASC accounts for the 2017 tax year. The Member Months Coverage Report provides data for each of our members enrolled for at least one month in one of our plans. The report will include:

- Account number
- Group number
- First and last name
- Date of birth
- Months covered for each member

We won't be soliciting Social Security numbers—we'll rely on you to accurately update this information through FileLink or BlueLinks prior January 1, 2018. Each account is responsible for sending the report file to your tax vendor and filing the data with the IRS.

To request a Member Months Coverage Report, please notify your account executive by **November 1, 2017**.

We Surpassed Medical Loss Ratio Requirements for 2016

Annually, insurers are required to meet federal and state medical loss ratio requirements. Insurers who don't meet both requirements must issue rebates to all clients and members.

For the reporting year of 2016, Blue Cross Blue Shield of Massachusetts won't issue rebates, as our loss ratio exceeded state and federal requirements for all market segments.
